

EXTENDED SERVICE WARRANTIES

All the warranted coverage shall be applied based on either time (ie. 6 months) or mileage (ie. 6,000 miles) whichever is to your advantage.

All services not indicated below are warranted for 6 months or 6,000 miles.*

WHO MAKES THIS WARRANTY

This warranty is made and will be serviced by the American Car Care Center that performed the repairs identified on the face of your repair invoice. This warranty will also be honored by any participating American Car Care Center nationwide, if you require warranty service ten (10) or more miles from the location where the warranted original service was performed, or, if necessary, at one of over 30,000 affiliated warranty repair facilities nationwide.

This warranty extends only to you, the original purchaser, and the motor vehicle identified on the original repair invoice. It applies only during the warranty periods stated in this folder.

WARRANTY AGREEMENT • ALL SERVICES

The American Car Care Center warrants that the performed repairs will be free from defects in material or workmanship for either 6 months or 6,000 miles, **whichever is to your advantage**, or the extended warranty periods for selected services as specifically outlined on the back of this folder.

If you experience a warranty-related problem with the repaired vehicle as the result of a defect in either workmanship or material during the warranty period, the American Car Care Center will perform the repairs again, including parts and labor, under the terms of the warranty as outlined. Warranty repairs do not extend original warranty periods.

Warranty authorization must be obtained from the Warranty Administrator prior to any warranty repair being performed, except if repaired at the American Car Care Center that originally performed the service. Please call the toll-free warranty hotline number.

Warranty repair costs are covered up to the cost of the original repair.

SERVICE WARRANTY POLICY

This warranty is only for you and the vehicle serviced. It is not transferable. This warranty does not include incidental or consequential damages, or additional expenses you may incur as a result of a faulty service or repair. Implied warranties shall be limited to the duration of this warranty and shall exclude consequential damages. This warranty gives you specific legal rights, and you may have other rights which vary by state.

Some states do not allow the exclusion or limitation of incidental or consequential damages, or allow limitations on how long an implied warranty lasts, so the above limitations may not apply to you (but in no event shall the inapplicability of such limitations or exclusions invalidate any other terms of this warranty).

This document contains all the terms and conditions of the Coast-to-Coast Nationwide Limited Service Warranty, which may not be modified in any way without the specific written consent of the Warranty Administrator.

HOW TO OBTAIN WARRANTY SERVICE

If you experience a warranty related problem, take this warranty and your repair invoice to the American Car Care Center that performed the service. If you are more than 10 miles from that location, call the warranty hotline, toll-free, and you will be directed to the nearest American Car Care Center.

Should additional assistance for warranty repair be required, simply call our Warranty Administrator at the toll-free warranty hotline. The toll-free warranty phone number is in operation 8:00 am to 8:00 pm Monday through Friday, 9:00 am to 6:00 pm Saturday, (Eastern Time). Roadside assistance is available 24/7.

EXCLUSIONS

This warranty does not apply to vehicles used commercially. This warranty does not cover tires and batteries (separate warranty available for ACCC tires) or internally lubricated transmission or engine repairs. For out of area tire service on vehicles equipped with Tire Pressure Monitoring Systems (TPMS), please check with the servicing dealership prior to having work performed to see if additional charges apply.

SERVICE WARRANTY PERIOD

A buyer of ACCC products or services has the right to have warranty service performed during the warranty period.

Repairs or service, including parts and labor as indicated on your original repair invoice, are covered for 6 months or 6,000 miles, whichever is to your advantage, subject to those exclusions listed elsewhere and those services which are covered by "Extended Warranties" as indicated at the back of this folder. Your warranted repairs are covered anywhere in the United States at an American Car Care Center, or one of over 30,000 affiliated nationwide warranty repair facilities.

These warranties apply only to parts and labor shown on your invoice - there may be other components in a system that are not covered.

The warranty period will be extended for the number of whole days that the vehicle has been out of the buyer's hands for warranty repairs. If a defect exists within the warranty period, the warranty will not expire until the defect has been fixed. The warranty period will also be extended if the warranty repairs have not been performed due to delays caused by circumstances beyond the control of the buyer, or if the warranty repairs did not remedy the defect and the buyer notifies the American Car Care Center which performed the warranted service of the failure of the repairs within 60 days after they were completed. If, after a reasonable number of attempts, the defect has not been fixed, the buyer may return his vehicle for a replacement of parts, if applicable, or a refund, in either case, subject to deductions of a reasonable charge for usage. This time extension does not affect the protections or remedies the buyer has under any law.
